SHIPPED SEMEN AGREEMENT

1. I agree to breed my mare _____ Reg. No.: _____
to the stallion known as: _____ for the 2004 season. I agree to
pay the sum of \$_____ plus collection fees, container and shipping expenses. Of this
amount, a booking fee of \$_____ is payable with this contract and the balance of
\$_____ is to be paid before any semen will be shipped.
 - a) There will be a \$250 collection fee for the first shipment of cooled semen. If it is necessary
for any further shipments of cooled semen a collection fee of \$225 for each additional
shipment will be charged.
 - b) There will be a container fee of \$250 for use of the container. If the container is returned in
72 hours you will be credited the \$250 deposit. Late Fee is \$50.00 per day starting at
day 3.
 - c) I agree to be responsible for all shipping costs.
 - d) Cooled semen will be shipped via Federal Express Monday through Friday. A \$200
shipping deposit is to be paid before the first shipment is due. Shipping expenses will be
deducted from this deposit. If there is extra money when the mare is settled, it will be
refunded to the mare's owner. If the shipping deposit is used up before the mare is settled,
an additional \$200 deposit must be paid before any additional shipments will be made.
 - e) Shipping on weekends can only be done from the airport -- a \$50 travel fee will be
deducted from the shipping deposit for each trip to the airport.
2. No cooled semen will be shipped to a delinquent account. Bills unpaid past 30 days, will be
charged a 2% per month late fee on the balance due.
3. Gibb Ranch will begin shipping cooled semen February 1, 2004. Mares on the premises of Gibb
Ranch have breeding priority; therefore, we make no guarantee that cooled semen will be
available on any specific day.
4. Gibb Ranch requires at least a 48 hour notice that your mare is due to come into heat and you
will be needing cooled semen. This is necessary in order to schedule our collection days.
5. You must notify Gibb Ranch by 12:00 p.m. (noon) Pacific Standard Time if you need to cancel a
shipment of cooled semen. If we are not notified, you will still be responsible for all collection,
container and shipping charges.
6. You must have your veterinarian confirm that the mare has ovulated. If the mare has not
ovulated, paragraph 4 still applies for all following shipments of cooled semen.
7. I agree that I will have my mare's ultrasound performed no later than the 18th day post ovulation.
In the event that the mare is not in foal, paragraphs 3 and 4 above still apply.

8. The booking fee guarantees the mare's owner one breeding in the stallion's current book. If the mare does not settle, the booking fee will not be refunded to the mare's owner, NOR will it be credited against any unpaid fees for collection or shipping.
9. The breeding season begins February 1 and ends July 1.
10. Stallion's agent guarantees a live foal from the breeding contract herein. A 'live foal' is defined as a foal that stands and nurses without assistance.
 - a) It is agreed that if the mare's owner does not get a live foal from this breeding, Stallion's Agent shall give mare's owner a rebreed, for the following year only, to the same horse, for the mare originally booked (unless a substitute mare is mutually agreed upon). At the end of that breeding season, the right to rebreed is cancelled and the Stallion's Agent is released from any further obligation whatsoever. Any and all fees paid shall not be refunded. The mare's owner is still responsible for collection, container and shipping fees.
 - b) If the mare proves to be barren, has a stillborn foal, aborts or dies before foaling, the mare's owner will contact the Stallion's Agent within one week. The mare's owner agrees to provide a statement from a licensed veterinarian.
11. In order for the live foal guarantee to remain in force and effect, the mare must receive Rhino Vaccinations in a timely fashion according to the recommendations of the mare's veterinarian.
12. A 'Breeder's Certificate' shall be issued upon notification of the birth of the foal, providing all accounts have been paid in full by the mare's owner. No Breeding Certificate will be issued until all fees have been paid and the stallion's owner has been provided with a color photo of the foal.
 - a) I agree that registration of the foal that comes from this breeding is my responsibility.
13. The owner of the mare hereby agrees to, and does, waive and release any and all claims against Gibb Ranch, Sherry Gibb, her agents and/or employees arising from the mare's breeding pursuant to this agreement.
14. A photostatic copy of both sides of the registration papers on the previously named mare MUST ACCOMPANY the signed contract and booking fee. The owner recorded on the Registration Papers will be recorded on the Stallion Breeding Report.
15. This contract cannot be assigned or transferred without prior consent.
